Financial Aid Information for NMSU Nurse Anesthesiology Program

The office of financial aid and scholarships is located at the Education Services building on NMSU's Main Campus. The address is Financial Aid & Scholarship Services, New Mexico State University, 1780 East University Avenue, Suite 600, Las Cruces, NM 88003.

The NMSU Student Financial Aid and Scholarship Department performs many functions, some of which include:

- prepares financial aid packages for students
- facilitates the application process for loans, scholarships, and other financial assistance programs
- provides counseling to all graduating students on loan payment options with individualized loan portfolios
- Advises on the financial aid process and can provide financial literacy and debt management strategies
- mitigate a student's special circumstances

Tuition and other educational expenses for the nurse anesthesiology (NA) program are about \$13,000/semester. The program is a full three years or 9 semesters at a total cost of approximately \$98,000 (this figure is subject to change). The NA degree program does not permit students to work during the program due to the intensity and rigor of the program. Many students will need financial assistance to cover the educational expenses while they are full-time students.

The amount that students can borrow is limited by their cost of attendance. This cost of attendance is calculated based on NMSU tuition, tuition differential, and program fees as well as an allowance for housing, food, transportation, books/supplies, and miscellaneous expenses. The allowances are made of a standard amount, taking into account if the student lives on or off campus, their career level (graduate school), and residency status (NM or out of state). The financial aid office is able to adjust the student's exact cost of attendance each semester, once the student is registered for classes.

Students that pay for child care for a dependent should connect with our office to see if an additional adjustment to their budget is available.

Distance education students may have higher travel expenses that the loans can cover. Students will need to fill out a contribution revision form found on the NMSU financial aid website (https://fa.nmsu.edu/forms/pj.html).

The financial aid office recommends that NA students start by utilizing their \$20,500 unsubsidized federal loan funds. And if they need additional financial assistance to cover their complete cost of attendance for the year, they may apply for the federal grad plus loan.

Scholarships, Grants, and Private loans

Other options for financial aid include scholarships, grants, and private loans.

<u>Scholar Dollar\$</u>: Our ScholarDollar\$ application process matches students with NMSU scholarship funds that they are eligible for, which eliminates the need to apply to individual university scholarships. NMSU distributes all of its scholarships and stipends through the ScholarDollar\$ system, therefore in order to be considered for a School of Nursing or NMSU scholarship, you must have an up-to-date application in the system.

• Public Service Loan Forgiveness Program.

It is currently going through some changes due to the loan forgiveness attempt by the current administration. The program helps place federal loan recipients in rural areas by nullifying any student loan repayments after the 10 year mark. For example, a student receiving \$10,000 in student loans, and enrolling in a qualifying repayment schedule, will only need to pay 120 (10 years worth) payments regardless of the remaining balance. There are certain stipulations in place with regards to the size of the community the post graduate job will be in, as well as the type of organization. Non-profit organizations and government run entities are preferred. Due to recent updates to the rules, research this more thoroughly. Student loans acquired during undergrad and the time period during school can count towards the 120 payments. Even while payments are deferred. Students coming from a nursing career in smaller communities should have a good chunk of that time taken care of already.

Nurse Corps Scholarship Program

This may be more difficult but one can apply once every year. There are several requirements such as graduates must work in qualified "Critical Shortage Areas" and the need for substance abuse education to patients. Qualifying recipients can expect up to \$100,000 of tuition help for 3 years of time allotted to working in these critical shortage areas. This amount was specific to graduating CRNA's. The students will have to contact someone at HRSA for more specific information with regards to the substance abuse education component of the requirement but this is a great opportunity.

NMSU degree programs are approved by the State Approving Agency (SAA) at the New Mexico Higher Education Department. Eligible students may receive education benefits from the U.S. Department of Defense or the U.S. Department of Veterans Affairs.

The Indian Health Service Loan Repayment Program (IHSLRP)

The Indian Health Service Loan Repayment Program (IHSLRP) is two-year service commitment in a *full-time clinical practice fulfilled at an eligible IHSLRP site. *IHSLRP defines full-time clinical practice as working a minimum of 80 hours every two-week period for an average of at least 40 hours per week. IHSLRP also stipulates that participants must spend at least 64 hours of the minimum 80 hours per two-week period providing direct patient care.

To apply for an IHSLRP award, please upload the following documents directly to your IHSLRP Database file:

- 1. Employment Verification: on an official letterhead (from an eligible Indian health facility) to include:
- a. Your full name:
- b. Position Title:

- c. Number of hours worked per week; and
- d. Start date.
- e. Government employees may submit an SF50 OR a CC Personnel Order
- 2. License to Practice: In your job specialty; include expiration date.
- 3. Loan Documentation: for loans taken for your degree; (including Consolidated Loans): statements showing:
- a. Current balance:
- b. Original disbursed amounts; and
- c. Original disbursement dates

IHSLRP will pay for undergraduate health profession education loans; as long as those studies were prerequisites for a graduate degree in the discipline in which you are applying for. Any non-health profession education loans or loans for family members that are consolidated with your qualified loans will not be paid. Each loan disbursements must match years toward your job specific degree. If you cannot locate a report with those details then you will have to contact your lender and request the loan origination details for this historical information.

- 4. Transcripts: (official or unofficial) with conferment dates of degrees to match loan disbursement years toward your job specific degree. At time of loan consolidation, if you had outstanding loans for other college or university, please forward those transcript(s) as well.
- 5. To qualify for Indian Preference (If applicable), submit BIA-4432 Form completed by your tribal enrollment office.
- 6. Recipient of another loan repayment or scholarship program (If applicable), submit a copy of your completion letter.

Include full pages regarding review documents; to capture identifying vendor letterheads, dates, and your account identification.
